PLEASE READ THE FOLLOWING

The purpose of the Central Texas Cricket League is to encourage and advance the game of cricket in the central Texas area. The League will develop relationships with the owners of grounds available for cricket and work to organize cricket games among teams made up of Members. In consideration of becoming a Member and participating in League organized games, each Member agrees to the following:

1. Membership. Each member must complete and sign this application and pay the required membership dues on an annual basis. Membership dues are not refundable.
2. Articles, Bylaws and Rules. Each member agrees to comply with the Articles of Incorporation, Bylaws and Rules of the League and support the activities of the League.
3. Board of Directors. The Board of Directors will make decisions relating to League business. All decisions made by the League's Board of Directors are final, including the expulsion of Members.
4. Games. Membership in the League by each player is required before that member may play in a League organized game.
5. International Cricket Council. Each member agrees to adopt and comply with the rules and regulations promulgated by the International Cricket Council.
6. Umpires. All decisions relating to a particular game are made by the Umpire. All decisions of the Umpire are final, however, the Umpire may consult with the players and reverse a decision. Should an Umpire fail to appear, or become unable to participate in a game, the captain of each of the two competing teams shall agree on a replacement umpire.
7. Grounds. Each Member agrees to comply with all ground rules, including keeping the grounds clean. Each team captain is responsible for providing the ground rules to the team members.
8. Prohibited Behavior. No fighting, swearing, arguing or physical or verbal abuse or assault is allowed. In addition to action taken by the Umpire, the League may warn the Member to cease and avoid the behavior, ban the Member from a number of games, or remove the Member from the League and forbid the Member from participating in any future games.
9. Disputes. A team captain may bring a dispute regarding a competition to the attention of the Board of Directors. Although the Board is not required, it may agree to resolve the issue by vote. The League will not involve itself in any disputes taking place off of the grounds.
10. Nature of Activity. Each member represents that he is qualified to participate in Cricket competition ("competition"). Each Member understands the dangers associated with competition, and that injury may occur due to the action or inaction of the Member or another player. EACH MEMBER FULLY UNDERSTANDS THAT COMPETITION INVOLVES RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH, AND EACH MEMBER FULLY ACCEPTS ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS AND DAMAGES INCURRED AS A RESULT OF THE MEMBER'S PARTICIPATION IN THE COMPETITION.
11. LIABILITY RELEASE. EACH MEMBER AGREES TO RELEASE, DISCHARGE AND COVENANT NOT TO SUE AND AGREES TO HOLD HARMLESS THE LEAGUE, ITS BOARD OF DIRECTORS, DIRECTORS, OFFICERS, AGENTS, VOLUNTEERS, EMPLOYEES, SPONSORS, OWNERS OR LESSORS OF THE GROUNDS (HEREINAFTER "RELEASEES"), FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY ANY ACT OR OMISSION OF THE RELEASEES IN CONNECTION WITH THE MEMBER'S PARTICIPATION IN THE LEAGUE OR OTHERWISE, AND FURTHER AGREE THAT IF THE MEMBER, OR ANYONE ON THE MEMBER'S BEHALF, MAKES A CLAIM AGAINST ANY OF THE RELEASEES NAMED ABOVE, THE MEMBER WILL INDEMNIFY, SAVE AND HOLD HARMLESS EACH OF THE RELEASEES FROM ANY LITIGATION EXPENSES, ATTORNEYS FEES, LOSS LIABILITY, DAMAGES OR COST ANY MAY INCUR AS THE RESULT OF SUCH CLAIM.
12. Health Insurance. The Member is advised to maintain comprehensive health insurance coverage.
13. Agency. A Member is not an agent of the League, cannot make decisions for the League, and the League is not liable for the actions of a Member. EACH MEMBER IS SOLELY LIABLE FOR HIS OWN ACTIONS.
14. History. The Member represents that he has not been removed, suspended or banned from participation or competition in any team, league, club, union or other such entity.
